




May 2013 High School Graduates Enrolled in 13/Fall by High School






Percentage of May 2013 High School Graduates enrolled in 13/Fall by High School




#### TOTAL STUDENT POPULATION

#### **ENROLLMENT STATUS**





### TOTAL STUDENT POPULATION CLASS LEVEL







### CREDIT HOURS FOR FALL SESSIONS DUAL CREDIT COURSES




#### FINANCIAL AID AWARDED








