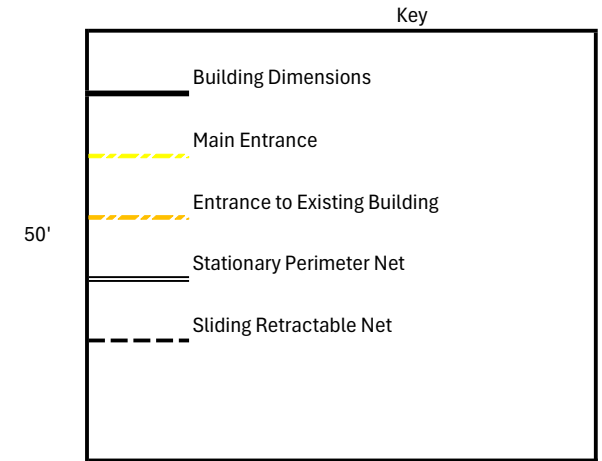
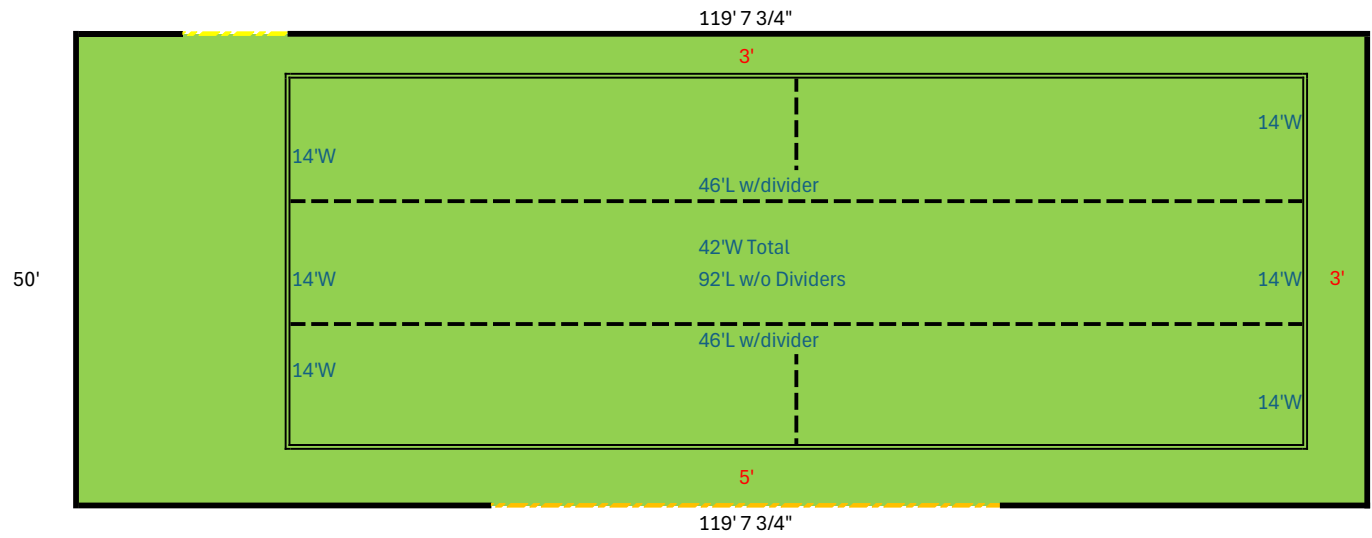


1. **DUTIES** The successful bidder agrees to provide a custom nylon net batting cage system for the College on the terms and conditions set forth in this agreement as follows:
2. **SUCCESSFUL BIDDER RESPONSIBILITIES** The successful bidder agrees to the following responsibilities:
 - A. Acquire and maintain all necessary licenses applicable to the duties to be performed.
 - B. Provide delivery with freight included in the bid price.
3. **SPECIFICATIONS** The successful bidder agrees to provide the following Custom Nylon Net Batting Cage System as specified below:
 - A. #60 Nylon Netting
 - B. Cables
 - C. Hardware
4. **NONDISCRIMINATION AND EQUAL OPPORTUNITY** The College commits itself to the policy that there shall be no unlawful discrimination against any person because of race, color, religion, sexual orientation, disability, age, gender, or national origin.
5. **CONTRACTOR** It is mutually understood and agreed that, where applicable to the terms and conditions set forth in this agreement, an independent contractor relationship is being established between the successful bidder and the College.
 - A. The employees of the successful bidder are not, nor shall be deemed to be, employees of the College.
 - B. The employees of the College are not, nor shall be deemed to be, employees of the successful bidder.
 - C. The successful bidder acknowledges that they are an independent contractor and are not an agent, partner, joint venture nor employee of College.
 - D. The successful bidder shall have no authority to bind or otherwise obligate the College in any manner nor shall the successful bidder represent to anyone that they have a right to do so.
6. **DAMAGE TO COLLEGE PROPERTY** The successful bidder shall be respectful of the College's property and shall report any damage as follows:
 - A. The successful bidder shall be responsible for the repair and replacement of any damage to College property caused by the misuse or negligence of the successful bidder or their employees.

- B. The successful bidder is responsible for reporting, in writing, within 72 hours the occurrence of damage to College property.
 - C. Failure to report the damage within the specified time may be cause for termination of this contract.
7. **BID ACCEPTANCE** The College reserves the right to accept or reject the successful bid in part or in entirety.
8. **PROPOSAL** The successful bidder shall supply the College with their proposal meeting the requirements included in this agreement. The proposal must include the following:
- A. A brief introduction and summary of your company.
 - B. Price proposal outlining the cost of the services defined in this agreement broken down as follows:
 - I. Cost of Custom #60 Nylon Net Batting Cage System w/ shipping
 - II. Installation of Custom Nylon Net Batting Cage System
 - III. Total Cost
